Stud fee³⁾ to the owner of the male dog

<input type="checkbox"/> The stud fee is based on the number of puppies. A so-called mating fee of EUR ²⁾ _____ is paid immediately after the mating has taken place and is not refunded. The actual stud fee of EUR _____ per puppy that qualifies for registration is paid later, on _____ / _____ 20____ or once the puppies turn seven (7) weeks of age. The mating fee paid includes all matings of the bitch during its heat referred to in this agreement.
<input type="checkbox"/> The stud fee is paid as single payment. The actual stud fee of EUR _____ is paid in full amount immediately after the mating has taken place. The single payment paid includes all matings of the bitch during its heat referred to in this agreement. Obligation to pay arises regardless of whether the bitch becomes pregnant or puppies are born.
<input type="checkbox"/> Parties have agreed on a re-mating, in which case the single payment or mating fee paid in accordance with this agreement is not re-paid in a situation where the mating has failed to result in a litter. A single puppy that reaches the age of seven weeks is considered a litter.
The owner of the bitch informs the owner of the male dog immediately about the birth of the puppies. Once the stud fee under this agreement has been paid in full, the owner of the male dog shall approve the litter, as required by the Dog Registry Guideline.

- 1) If the dog is sent to the place of mating, the parties shall agree on the means of transportation and costs thereof as well as the costs for the dog's care at the place of mating (feeding, possible veterinary costs etc.). It shall also be agreed which party is liable for the dog during the duration of the agreement.
- 2) A mating fee is a one-time compensation for mating.
- 3) If a puppy is agreed as the payment of the stud fee, which is not recommended, a separate agreement regarding the male dog owner's right to choose a puppy, the time of delivery of the puppy, as well as an agreement regarding the procedure in case the puppies are born dead or if only one puppy is born, shall be made.

Disputes regarding this agreement should be resolved through negotiations between the parties. If no settlement is reached, the parties can contact the Consumer Advisory Service. The consumer party can then refer the dispute to the Consumer Disputes Board (www.kuluttajariita.fi) in order to receive a recommended decision. A final decision to the dispute is obtained by bringing an action before the district court (www.oikeus.fi)
A copy of this agreement has been made out for each party.
